# APNIC

- ★ **Internet Assigned Numbers Authority (IANA) policy for allocation of IPv6 blocks to Regional Internet Registries (prop-005-v005)**
  - ▶ final call
  
- ★ **Proposal to amend APNIC IPv6 assignment and utilisation requirement policy (prop-031-v001)**
  - ▶ Defines additional assignment of /56 for SOHO
  - ▶ Utilization based on /56
  - ▶ HD Ratio changes from .8 to .94
  - ▶ Consensus for changing the HD Ratio to .94. – final call

# APNIC

- ★ **Deprecation of ip6.int reverse DNS service in APNIC (prop-030-v001)**
  - ▶ Final call
- ★ **Abolishing IPv6 per address fee for NIRs (prop-028-v001)**
  - ▶ Final Call
- ★ **Proposal for discrete networks and national peering (prop-029-v002)**
  - ▶ Abandoned

  - ▶ LACNIC Board review
- ▶ **IPv4 additional allocation policy for International ISPs**
