about ARIN

what is ARIN?

The American Registry for Internet Numbers (ARIN) is a nonprofit, member-based organization whose primary role is managing the distribution of Internet number resources (IPv4 and IPv6 addresses and Autonomous System Numbers [ASNs]) to entities within its service region. Established in December 1997 in Chantilly, Virginia, ARIN is one of five **Regional Internet Registries** (RIRs) that not only ensure the uniqueness of IP addresses and ASNs but also support the operation and growth of the Internet through technical coordination, collaboration, and the promotion of the participatory policy development model. ARIN, as a responsible steward of Internet number resources within its region, contributes to sustainable Internet development by ensuring the transparency of the distribution process, the accuracy of registration data, and the openness of the communitydriven policy development process.

services offered

Registration Services

ARIN's primary function is the allocation and transfer of Internet number resources, but ARIN also maintains Whois and Whowas records, reverse delegation registration (also known as reverse Domain Name System [DNS]), and help desk and customer support services.

Technical Services

ARIN develops, implements, and supports both internal systems and community services like ARIN Online, Registration Data Access Protocol (RDAP), the Internet Routing Registry (IRR), and Resource Public Key Infrastructure (RPKI).

Organization Services

ARIN coordinates meaningful interaction between members, stakeholders, and the organization through the facilitation of an inclusive policy development process, information services and mailing lists, outreach and education, and community engagement.

To our valued community,

2024 was a year of growth, engagement, and steady progress for ARIN. Guided by our mission to securely and efficiently manage Internet number resources, ARIN made improvements across the organization to deliver top-tier services, expand our community engagement, and strengthen our organization's resilience.

Providing industry-leading Internet number registry services remains our primary goal. This past year, we made significant advancements – enhancing existing tools, streamlining services, and modernizing outdated systems. Notably, we successfully completed our transition off email-based resource reassignment to our more secure ARIN Online platform. This transition involved extensive outreach and direct community support, ensuring a smooth shift to improved tools and processes.

Improving Internet routing security continued to be a high priority. In 2024, we delivered key updates to ARIN's Resource Public Key Infrastructure (RPKI) to simplify usage and improve the customer experience.

Our community outreach and engagement efforts continued at a brisk pace, with our outreach activities supporting a diverse range of stakeholder groups as outlined in this report. Maintaining the multistakeholder model for coordination of Internet number resources is essential, so we continue to engage with governments, law enforcement agencies, and a broad range of customers across the region.

To ensure ARIN's long-term financial sustainability, we established a long-range financial plan that provides a structured approach to budgeting, expense management, and reserve planning. The financial model, developed over the past year by the Board of Trustees and described at the ARIN 54 meeting, helps ARIN: maintain appropriate financial reserves by aligning revenue with operational needs; provide cost discipline; and sustain funds for future investments in registry services and infrastructure. By proactively managing our financial position per the model, we can continue delivering critical services,




absorb unforeseen challenges, and support the evolving needs of the Internet community.


ARIN membership

All ARIN customer organizations with Internet number resources under an ARIN Agreement are Service Members and may choose to participate in ARIN governance by requesting General Membership.


Membership is not a requirement for attaining direct Internet number resources from ARIN, nor does it offer any advantage in doing so.

routing security

ARIN encourages members of the Internet community to certify their resources through Resource Public Key Infrastructure (RPKI). Internet routing today is vulnerable to hijacking and the provisioning/use of certificates is one of first steps required to make routing more secure.

In 2024, ARIN promoted RPKI adoption to our community with various webinars, training opportunities, and in-person Deployathons.

ARIN completed various enhancements to our RPKI service, including the release of our IRR Auto-Manager in November 2024, which generates an Internet Routing Registry route object during Route Origin Authorization creation. All statistics are as of 31 December 2024.



The ARIN Board of Trustees establishes and maintains authority over ARIN's scope, mission, and strategic and fiscal direction. The Board also oversees committee nominations, appointments, and elections and votes on community-developed draft policies in accordance with the Policy Development Process (PDP).

In 2024, the Board consisted of nine members. Eight members were elected by ARIN's General Members, and the President and CEO of ARIN, John Curran, served as the ninth member.

In 2024, the Board held four in-person meetings. The rest of the meetings were held via teleconference. See Appendix A for the actions taken by the Board in 2024.

ARIN FELLOWSHIP PROGRAM

To encourage and foster new voices in the ARIN community, our Fellowship Program provides an interactive learning

Fellows are selected twice a year to participate in the multiweek program before and during an ARIN Public Policy and Members Meeting. Fellows receive an in-depth introduction from their community Mentors to the ARIN organization and the Policy Development Process (PDP) to facilitate their participation.

The proposed project seeks to shed light on Internet abuse by developing live indicators that provide information about how numbering resources are misused in phishing and malware attacks in order to raise awareness of this issue among network operators and incident response teams to enable informed action.

ARIN ELECTION

2024 ELECTION RESULTS

Board of Trustees

Ron da Silva was elected to the ARIN Board of Trustees, and incumbents Peter Harrison and Chris Tacit were reelected to the Board of Trustees. Each will serve a three-year term that began 1 January 2025.

Advisory Council (AC)

Lily Botsyoe and William Herrin were elected, and incumbents Kathleen Hunter, Chris Woodfield, and Alicia Trotman were re-elected to the AC for three-year terms that began 1 January 2025.

Number Resource Organization Number Council (NRO NC)

Amy Potter was elected to a seat on the NRO NC from the ARIN region. Her three-year term began 1 January 2025.

VIRTUAL CANDIDATE FORUM

As part of the 2024 ARIN Elections, ARIN hosted a virtual Candidate Forum on 16 October. The forum provided voters – and the whole ARIN community – with the opportunity to learn more about the candidates running for the Board of Trustees.

The Candidate Forum was moderated by ARIN's General Counsel, Michael Abejuela, and ran for approximately 90 minutes. It was simultaneously presented via Zoom webinar and livestreamed on the ARIN YouTube channel.

14-17 April 2024 Bridgetown, Barbados

The ARIN 53 Public Policy and Members Meeting was held in the Caribbean just before the 27th Regional Gathering of the Caribbean Network Operators Group (CaribNOG).

MCNET-SOLUTIONS CTO Brent Mc Intosh, who is from Grenada and was recently inducted into the IPv6 Forum Hall of Fame for IPv6 evangelism, delivered the keynote address. Brent discussed boosting the Caribbean's economic potential through deployment of the critical digital infrastructure of IXPs and IPv6.

Between ARIN 53 and CaribNOG 27, ARIN hosted a lunch for prominent Caribbean officials as well as an RPKI Deployathon hands-on workshop.

Attendees also had the opportunity to ask questions and provide feedback at a Registration Services Help Desk.

government outreach

The Government Affairs Department (GAD) continued its efforts in 2024 by meeting strategic guidance objectives and advancing ARIN community interests. Government, public safety, industry, and law enforcement colleagues continued to rely on the GAD team for their coordination, knowledge, and support while providing an opportunity to keep them apprised of Internet numbering, Regional Internet Registry activities, and ARIN policy matters.

AREAS OF FOCUS

International Telecommunications Union's Partner2Connect Program Intended to advance informational and communications technologies for areas in need while achieving other United Nations Sustainable Development Goals.

Messaging, Malware, and Mobile Anti-Abuse Working Group (M3AAWG)

Deliverables included providing M3AAWG's Best Current Practices to the Internet Corporation for Assigned Names and Numbers (ICANN) for their consideration and facilitating a panel discussion regarding IPv4 leasing at the Vienna M3AAWG meeting.

Caribbean Law Enforcement Leaders Symposium

Senior law enforcement leaders, public sector cyber security officials, public prosecutors, and the Judiciary joined to advance public safety and judicial process outcomes in the Caribbean.

World Telecommunications Standardization Assembly

The GAD team worked with "Resolution 64 - Internet Protocol address allocation and facilitating the transition to and deployment of Internet Protocol version 6" and "Resolution 20 - Procedures for the allocation and management of international telecommunication numbering, naming, addressing and identification resources."

GOVERNMENT INITIATIVES

GAD conducted analysis and provided constructive input to the following government initiatives, ensuring the interests of ARIN and its community were visible to lawmakers.

- Canadian Bill C-27 (the Consumer Privacy Protection Act, the Personal Information and Data Protection Tribunal Act, and the Artificial Intelligence and Data Act)
- Proposed Rule for Cyber Incident Reporting for Critical Infrastructure Act of 2022 (Cybersecurity and Infrastructure Security Agency)
- Reporting on Border Gateway Protocol Risk Mitigation Progress (Federal Communications Commission)



CONNECTED CARIBBEAN SUMMIT 2024

The Summit advocated for advancing digital efforts in the Caribbean across three arenas: Business, government, and the legal sector. The program was further enhanced by a keynote address by ARIN President and CEO John Curran as well as participation by ARIN Trustees Bill Sandiford and Peter Harrison. This annual effort continues to advance digital transformation in the Caribbean.

policy development

ARIN ADVISORY COUNCIL

The Advisory Council (AC) serves in an advisory capacity to the Board of Trustees on Internet number resource policy and related matters. Adhering to the procedures in the Policy Development Process, the AC forwards consensus-based policy proposals to the Board for ratification.

The AC consists of 15 elected members. The President of ARIN is an ex-officio member and acts as the liaison between the Board and the AC.



INFORMATION SECURITY

In October 2024, ARIN recertified compliant with SOC 2 and PCI DSS. As part of our commitment to security, we successfully hosted a Board-level cyber incident response exercise, and we released a tool to staff for reporting phishing emails. With a focus on maintaining the privacy of customer and staff data, we adopted a generative artificial intelligence usage policy for staff and volunteers.

ENGINEERING

ARIN's Engineering team had four releases in 2024, with work focused on Resource Public Key Infrastructure improvements, retirement of email templates, and more. Work continues with the Internet Engineering Task Force on RDAP features, as well as on internally reducing our technical debt and updating various applications. ARIN engineers helped install a new DNS-only site on St. Kitts in conjunction with our Government Affairs Department.



HUMAN RESOURCES & ADMINISTRATION

In 2024, ARIN hit the 100+ employee mark, and we are proud to say that our average employee tenure remains strong. ARIN provides its employees with many benefits, including office events for crossdepartmental connections, a robust retirement plan, and charitable opportunities.





INCLUSION AND DIVERSITY EFFORTS AT ARIN

ARIN ramped up its inclusion and diversity efforts in 2024.

We continued providing an ombudsperson at our ARIN Public Policy and Members Meetings, and we published an enhanced Participants Expected Standards of Behavior for ARIN-hosted events and mailing lists in order to provide a safe atmosphere for all members of our community.

We hosted inclusion and management training for people managers, and scheduled full staff and volunteer inclusion training for 2025.

BUDGET


The Financial Services Department (FSD) prepared 32,200 invoices in 2024, with total billings at US\$29.5 million. Approximately 2,250 service calls were completed by the accounts receivable team to help our customers with billing issues. FSD also finalized a financial strategy with the Board of Trustees that is committed to achieving a balanced budget.

COMMUNICATIONS

The Communications team plays a key role in helping our customers stay informed of ARIN activities. The team provided significant interdepartmental support for various member initiatives and programs. Work began on ARIN's training platform, ARIN Academy, with an eye toward launch in 2025. The team also continued to maintain and promote the ARIN website and ARIN Blog, as well as ARIN's social media accounts.



CUSTOMER EXPERIENCE & STRATEGY

The Customer Experience & Strategy team continues to aggressively focus on internal and external process and tools improvements. One of the major process improvements in 2024 was a significant reduction in resolution time for transfers. Two new teams were established for 2025 to expand on our focus of technical service support and registry integrity.

The NRO Number Council (NRO NC) fulfills the role of the Internet Corporation of Assigned Names and Numbers (ICANN) Address Supporting Organization Address Council (ASO AC), providing advice to the Board of ICANN on global Internet number resource policy, in conjunction with the RIRs.

Kevin Blumberg, Nick Nugent, and Christopher Quesada served as NRO NC representatives for the ARIN region in 2024.

ARIN staff worked with the NRO and NRO NC on various initiatives in 2024, including the NRO Resource Public Key Infrastructure (RPKI) Program and the update of Internet Coordination Policy 2 (ICP-2).


