## **Casting Your Organization's Vote**



- An organization must have been a General Member in Good Standing with a designated Voting Contact as of 4 September.
- Organizations could update their Voting Contact after the Voting Eligibility deadline, but all changes had to be finalized at least seven days before the voting period begins, which was Thursday, 12 October 2023, at 3:00 PM ET.




After 3:00 PM ET / Noon PT today, Eligible Voting Contacts should:

- 1. Log in to **ARIN Online.**
- 2. Select the "**Vote Now**" link.
- Cast ballots for the Board of Trustees and Advisory Council.

#### Voting is open now through 7:00 PM ET on 27 October.

#### **Your Ballot**






When viewing your ballot, you will see:


