# Current policy: 2003-3 (and NRPM sections 4.2.3.7.6. and 6.5.5.1.):

An organization with downstream residential customers may substitute that organization's name for the customer's name, e.g. 'Private customer - XYZ Network', and the customer's **street address** may be replaced with 'Private Residence'. Each private downstream residential reassignment must have accurate upstream Abuse and Technical POCs visible on the WHOIS record for that block.

### Interpretation of 2003-3?

Earlier version(s) of proposal 2003-3 used the words "residential address information".

"Residential address information" appears in minutes of ARIN XI (Memphis).

From PPML:

"The purpose is to protect individuals' privacy, specifically name and home address."

"My mother's name and address should not be listed in the ARIN database."
