Motivation to Serve on the Board of Trustees

- Depletion of the IPv4 address space will occur during the upcoming board term. I will continue working to make sure that speculators are not allowed to victimize ISPs in their continuing need for IPv4 addresses. This requires a strong and simple transfer policy, without loopholes to be exploited by speculators.
- ARIN's membership structure and fee schedule are in need of minor rationalization and simplification. That's a process that the board has begun, partly under my subcommittee chairmanship, and it's a process that I'll see through to completion. All ARIN resource recipients should be entitled to vote, and I don't think anyone who can't qualify for address space should tell us how to run our businesses.

Qualifications

- I operate an IPv4 / IPv6 dual-stack network in thirty-one countries, with seven hundred unique peers and more than two thousand active peering sessions, carrying critical traffic for two of the thirteen root nameservers, and forty country-code top-level domains, including .US and six others in the ARIN region. I started my first ISP in 1989, and it's operating today with 20 consecutive years of continuous profitability. During those twenty years, I've also started more than a dozen other successful Internet service companies, and contributed my time to a similar number of non-profits in the Internet infrastructure and policy domains. I've helped found more than three dozen Internet exchange points, and serve on the advisory boards of several dozen.
- I have as much skin in the game as anyone in this room. You all know that I do things the same way you would, why I do so, and why I'll continue to do so. I hope that you'll re-elect me to a third term on the ARIN board.
