- AfrinIC is very happy to participate in this ARIN regional meeting.
- We are also happy to meet our future members from this part of Africa. For us it is the first significant event where we are getting in touch with you.

What AfrinIC is for?

- Registering and managing Internet resources distribution in Africa Region.
- What do we mean by Internet Resources?
 - ◆ NUMBERS used to uniquely identify different components on the net.
 - ★ **IP addresses**
 - ★ **Autonomous System**
- AfrinIC is not related to **NAME** (domain name) but only **NUMBERS**.

Brief History

- Today Africa is served by RIPE NCC (north of the equator), ARIN (south of the equator) and APNIC (Indian Ocean)

- African ISP's agreed in a global consensus in 2000 to create their own Registry.

- AfrinIC - African Network Information Center
 - ◆ To become the 5th Regional Internet Registry
 - ◆ Also serving Indian Ocean Region (Zanzibar, Seychelles, Madagascar, Mauritius).

Key dates in AfrinIC process

- ▶ **May 2001: Interim board Elected (Accra)**
- ▶ **January 2002**
 - 1st public Board Meeting , Cairo, Egypt*
 - **Draft of the first AfrinIC incorporation plan (under revision).**
 - **Discussion started with RIPE NCC for incubation.**
- ▶ **May 2002: (AFNOG III)**
 - Board Meeting and status report to local community, Lomé TOGO*
 - **Agreement signed with RIPE NCC.**
 - **Received statement off support from ARIN.**
- ▶ **August 2002:**
 - 2nd public Board Meeting , Nairobi, Kenya*
 - **Decision to hire Staff.**

Key dates in AfrinIC process

- **Feb 2003**: Call for hosting country proposals
- **May 2203** (Kampala): Selection of hosting countries:
 - ◆ *Via consensus from the applicants, it was decided to distribute AfrinIC activities across 4 locations (on incorporated entity).*
- **January 2004**: Relocation of AfrinIC staff in South Africa.
- **May 2004**: First Public policy meeting in Dakar

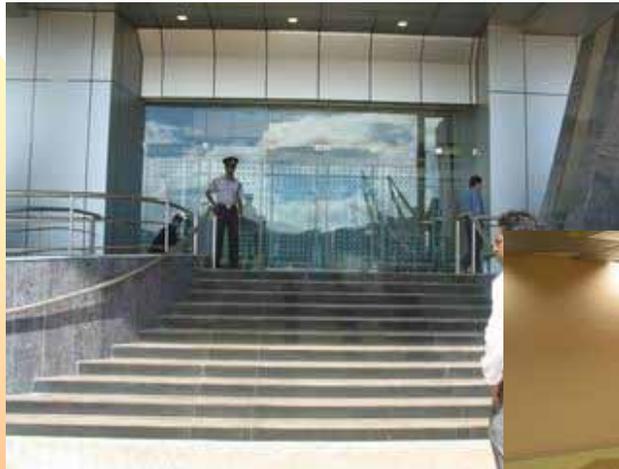

Why a transition plan?

- Africa is served by 3 RIRs
 - ◆ Need for harmonization
 - ◆ Need for consistency

- LIRs and stakeholders need to be confident with the setup process
 - ◆ Need for clear milestones
 - ◆ Need for action plan
 - ◆ Need for commitment from RIRs
 - ◆ Need referral point to evaluation progress made.

AfrinIC transition Plan

- Transition is organized in 4 Phases apply to the tree different RIRs serving our region.
 - ◆ Technical, Business
- **Phase 0: *Preparation***
- **Phase 1: *Co-evaluation & AfrinIC Database/Whois setup***
- **Phase 2: *Uniform policy and Evaluation with second approval by RIRs.***
- **Phase 3: *Provisional Recognition & Independent evaluation with Audit by RIRs***

Phase 0 - Details

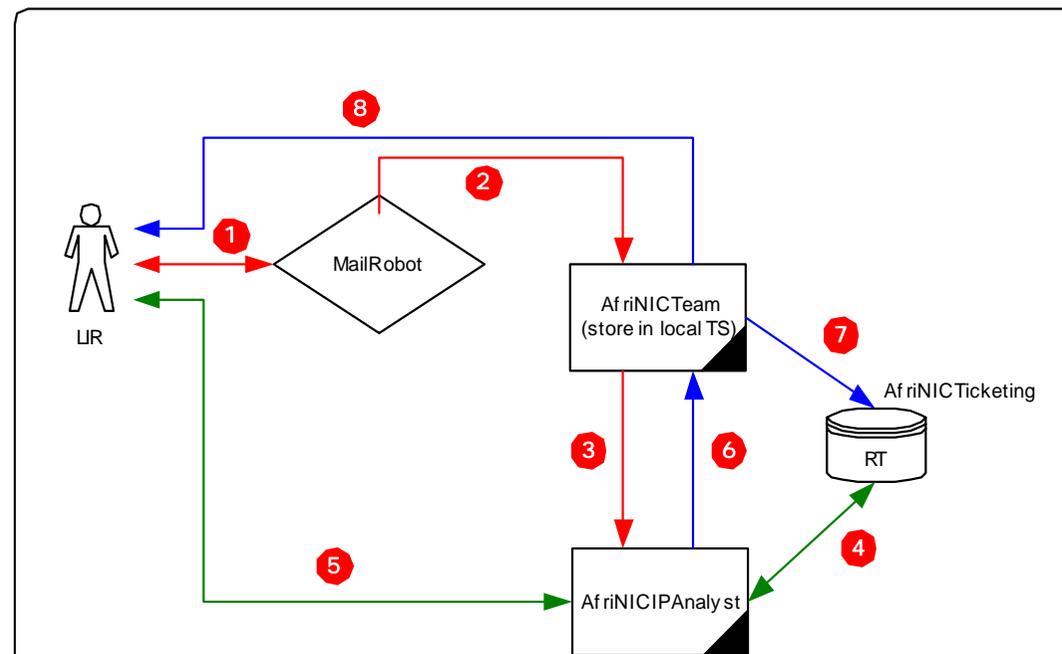
- Training: AfrinIC staff to spend time with RIRs to gain more experience in their operation – Done (at RIPE NCC)
- Staff Relocation – done
- Physical Office setup
 - ◆ South Africa – done
 - ◆ Mauritius – Ongoing
- Infrastructure setup and Agreement on Technical Transition - Ongoing
 - ◆ Network architecture design - done
 - ◆ Connectivity – done
 - ◆ Servers and Network equipments acquisition – done
 - ◆ Tools and software identification – done

Phase 0 cont

- Infrastructure setup - Ongoing
- Procedure/Policy - ongoing
 - ◆ Policies draft – done
 - ◆ RSA Draft - done
 - ◆ Supporting documents – ongoing
 - ◆ Procedure - ongoing
- Final agreement on Transition process – Ongoing
- Budget and financial plan - done

Phase 1 (1/2)

- Start of co-evaluation – Start with RIPE NCC and followed one month later with ARIN
- Each community will be informed on time about the changes involve at this stage



Phase 1 (cont)

- Application for recognition (ICANN ICP2)
- AfriNIC database design and setup
- AfriNIC WHOIS DB Setup
 - ◆ Choose to use RIPE WHOIS/DB
 - ◆ DB Procedure will then be similar to RIPE
- **Uniformization** of forms and Procedure for resources allocation in Africa region.

Phase 2 (1/2)

- Will start after Application for formal recognition
- New members will be officially informed about AfrinIC and be asked to sign two agreements (RIRs and AfrinIC's one)
- AfrinIC will serve as secondary DNS for 196/8
- Co-evaluation continues
- AfrinIC finalizes its Information System (billing system and its interaction with registration service...etc..)

Phase 2

- Setup web based tools for members
- Prepare and document Data (registration and financial) transfer from the different RIRs to AfrinIC system
- Prepare and document transfer of 196/8 reverse DNS to AfrinIC.
- Test and validation of Data transfer process
- Supporting documents review

Phase 3

- Provisional recognition from ICANN (expected for Dec'04)
- Data transfer agreement between AfrinIC and ARIN/RIPE NCC/APNIC (Dec'04).
- Effective data transfer start (Jan'05)
- Full service based on adopted policies (Jan-Feb'05)

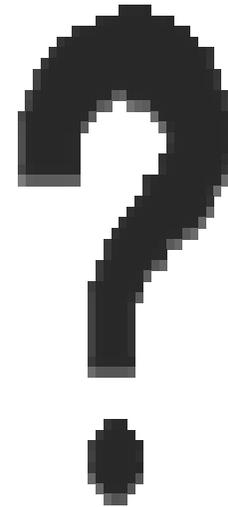
So ...

- Key policy documents are adopted
- Offices are setup, staff are operational

- International community support
- We financial plan (Sustainability)
- We have a transition plan
