## Internet Community Meeting Reports

### IETF 66

9-14 July  
Montréal, Canada

The 66th IETF meeting was held from 9-14 July in Montréal, Québec. Of particular interest to the ARIN community were discussions focused on Secure Inter-Domain Routing (SIDR), a proposed method for creating a PKI that reflects the allocation of resources through Regional Internet Registries. In the SIDR Working Group, discussion included the length of the public encryption key, the time a certificate should be valid for, and operational issues. This topic was also discussed in a joint forum between the SIDR working group and the Public Key Infrastructure Using X.509 (PKIX) Working Group, with a presentation and follow-up discussion on Resource Cert AS path certification.

Earlier in the week, ARIN President and CEO Raymond A. Plzak provided a report on the Number Resource Organization to the Internet Engineering and Planning Group (IEPG), an informal group that meets prior to IETF meetings. His report included an overview of NRO activities, an Internet resource status report, and information on policy proposals that are currently active across the RIR regions.

### Joint Techs Workshop

The Summer 2006 ESCC/Internet2 Joint Techs Workshop was held in Madison, Wisconsin from 16-19 July 16 2006.

The meeting featured a number of workshops, BoFs, and technical discussions. ARIN Director of External Relations Richard Jimmerson provided an update on ARIN operations and issues of interest.

### APNIC 22

4-9 September

#### Kaohsiung, Taiwan

APNIC 22 was held in Kaohsiung, Taiwan from 4-8 September, 2006. A total of eight policy proposals were discussed, with the following four proposals reaching consensus and being forwarded on to last call:

- prop-033: End site assignment policy for IPv6
- prop-035: IPv6 portable assignment for multihoming
- prop-038: Modified lame DNS policy proposal
- prop-041: IPv6 assignment size to critical infrastructure

In addition, prop-039: "A proposal to improve reachability of new IANA blocks" reached partial consensus, and elements of this proposal are also being put up for last call.

An election to fill the Asia Pacific seat on the NRO Number Council that becomes vacant on 31 December 2006 was held, with Hyun-Joon Kwon winning the seat.

This document outlines the process by which the ARIN Board and Executive may ask for comments on specific issues relating to ARIN services and practices, and provides a mechanism for the community to make suggestions regarding existing or potential services and practices at ARIN.

## ARIN Board of Trustees Actions

The ARIN Board of Trustees met on 11 July and 27 July 2006.

The following are highlights of Board actions and discussions at these meetings:

- Discussed and adopted a contracting process that would involve informing the ARIN community and receiving feedback on certain contracts entered into by ARIN.
- Approved ARIN staff working with RIPE and APNIC to determine a process by which resource records can be signed.
- Adopted the ARIN Consultation and Suggestion Process.
- Accepted the 2005 audited financial statements, as presented.
- Adopted the IPv6 Initial Assignment fee schedule and a waiver of all but \$500 of the IPv6 Initial Assignment fee through 31 December 2007.
- Adopted version 2006.2 of the Number Resource Policy Manual.

## NRPM version 2006.2 - New Policy Implementations

On 9 May 2006, the ARIN Board of Trustees, based on the recommendation of the Advisory Council and noting that the Internet Resource Policy Evaluation Process had been followed, adopted the following policy proposals:

- 2005-1: Provider-independent IPv6 Assignments for End Sites
- 2005-8: Proposal to amend ARIN IPv6 assignment and utilisation requirement
- 2005-9: 4-Byte AS Number

These policy proposals have been incorporated into version 2006.2 of the ARIN Number Resource Policy Manual (NRPM) which is effective 30 August 2006.

NRPM version 2006.2 supersedes previous versions. See Appendix A of the NRPM for information regarding changes to the manual.

## 2006 Election Information

Designated Member Representatives (DMRs) from ARIN General Members in good standing (GMIGS) are eligible to vote in the Board, Advisory Council, and NRO Number Council elections.

- As announced, the deadline for establishing voter eligibility was 29 September 2006.

NANOG 38 and ARIN XVIII attendees will receive information about how to vote onsite at the meeting. For those eligible to vote as the DMR of an ARIN member in good standing, voting will be open Wednesday, 4 October, 12:00 through Wednesday, 11 October, 17:00 (EDT).

The winner of the NRO Number Council election will be announced Thursday, 12 October, during the second day of the ARIN Public Policy Meeting. The Board and Advisory Council results will be announced via e-mail to the arin-announce mailing list and on the ARIN website on Friday, 27 October.

## Information About New ARIN Templates

On 31 August 2006, ARIN released new versions of all registration templates based on feedback from the community and the experiences of ARIN staff. These revisions were made with the intention of making them clearer, more concise, and easier to complete.

In addition, some templates were revised to reflect changes necessary for upcoming policy implementations.

After 31 August 2006, all new requests for IP addresses and Autonomous System numbers must be submitted using these revised templates. ARIN will continue to accept the previous versions of other templates for at least one year so that customers using scripts will have sufficient time to update their software. It is recommended that all other customers use the new templates to ensure more efficient processing.
