- 1. Reduce the length of time nominations is open from a month+ to three weeks.
- 2. Allow adequate time for the NomCom to conduct an initial screen of nominees.
- 3. Allow adequate time for Board nominee background checks to be requested, processed, and provided to the NomCom Chair for review/discussion.
- Allow the NomCom adequate time to schedule and host nominee phone interviews. (Board nominee interviews are required and Advisory Council nominee interviews are at the discretion of the NomCom.)
- 5. Allow adequate time for the NomCom to review, meet, and discuss nominees.
- 6. Allow adequate time for the Call for Nominations to be reopened if required by the NomCom.
