Explanations for Larger Variances



- Salaries & Fringe (\$151,611) ARIN Online capitalized salaries & fringe were lower than budget
- Depreciation \$413,207 -The variance is purchasing computer hardware later than budgeted and building costs under budget for CCD
- Professional Fees/Outreach \$240,570 Consulting and outreach travel expense lower than budget
- Legal Fees \$261,940 Our outside legal firm was not as active this year but plans to increase in 2017
- Rent & Occupancy \$497,539 Budgeted a rent buyout in August for 3635
 Concorde Parkway Building. ARIN continues to pay monthly for former facility lease, rather than buyout
- Travel \$222,942 Attendance at several meetings exceeded budget
- Internet Research (\$1,000,693) IETF Endowment not in the 2016 budget

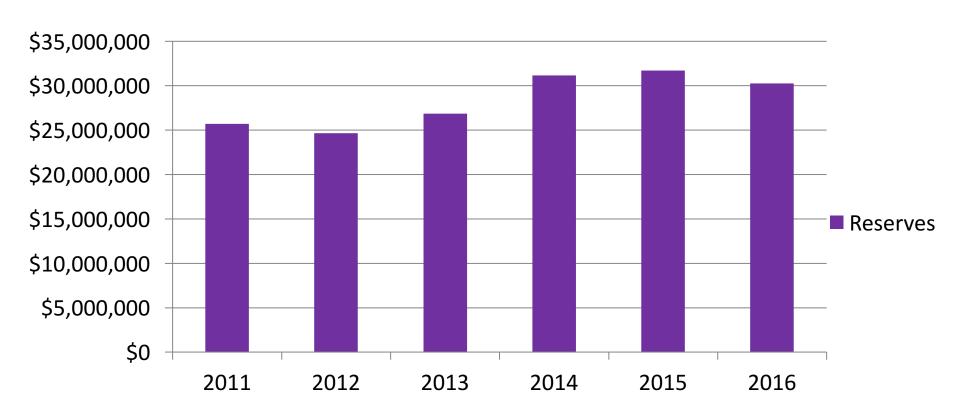
Financial Reserves Through Year End

 - Operating Reserve Fund To provide short-term financial stability for ARIN. Balance at 12/31/16 \$4,194,313
 - Long Term Reserve Fund To provide long-term financial stability for ARIN. Balance at 12/31/16 \$23,969,185

Explanations for Larger Variances



- Salaries & Benefits (\$1,110,083) Increase in personnel due to 1) hiring experienced replacements for Senior Director of Registration Services and Executive Director of Government Affairs and Public Policy 2) Registration Services Analysts vacancies filled with legal experienced personnel, i.e. paralegal and attorney, 3) health care cost increase, and 3) reaching full staff
- Software & Support (\$273,948) Dell server support has increased due to ARIN keeping servers in production longer than expected and maintenance for some equipment was bundled into the purchase price and now, after the first year, is purchased separately
- Depreciation (\$1,059,223) Depreciation costs increase due primarily to the new facility and new furniture related depreciation
- Rent & Occupancy (\$268,025) Increase due to new facility as well as carrying prior facility. ARIN continues to pay monthly for former facility lease, rather than buyout.
- Internet Research & Support \$1,020,693 2016 higher due to the IETF Endowment funding
