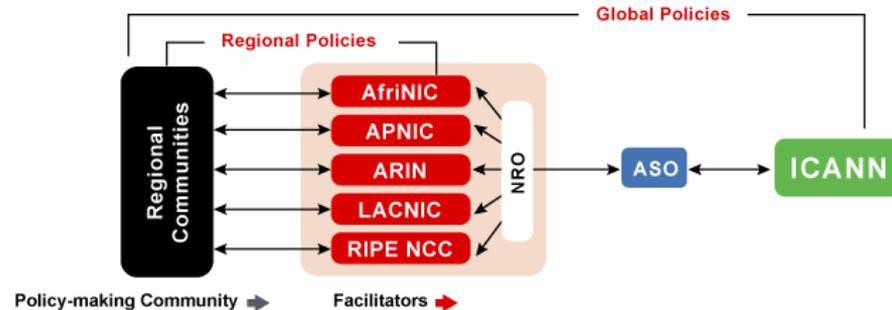

ASO/AC Activities: Global Policy Management

- A Global Policy
 - “Global policies are defined within the scope of this agreement as Internet number resource policies that have the agreement of all RIRs [Regional Internet Registries] according to their policy development processes and ICANN, and **require specific actions or outcomes on the part of IANA or any other external ICANN-related body** in order to be implemented.” - ASO MoU -
 - Global policies determine number allocation policy for requests that involve IANA
 - Global policies may also specify regional number allocation policy

Global Policy Development

- Each region has its own policy development process
 - All open, transparent, and bottom-up
- Global policy proposals are submitted in all 5 regions
- Each region follows its own process
- It then gets passed to the NRO for review
- And forwarded to the ICANN board



ASO/AC Activities: Global Policy Management

- Currently, there are currently no Global Policy Proposals
- We've been observing each RIR's policy forum if new global policy is proposed.
