Disallow Third-party Organization Record Creation (org-id)

### What is an org-id?

#### What is an organizational record? (ARIN

ARIN 43

- These records are also often called org-ids
- An Org-id contains information about the top-level "legal" entity that is doing business with ARIN OR the organization which has received a detailed reassignment or allocation
- A typical Org-id has the following public fields
  - Name: Bob's bait and sushi, Inc.
  - Handle: BOBB
  - Address: 123 Waterfront Road
  - City: Bridgetown
  - State:
  - Postal Code: 15156
  - Country Code: BB
  - Registration Date: 2004-01-12
  - Last Updated: 2018-11-02
  - Comments:
- Org-ids are referenced by resources records, such as
  - IPv4 & IPv6 blocks
  - ASN records
  - Point of contact (POC)

## How are Org-ids created today? (ARIN



- In ARIN online
- Via an email template
  - Org template
  - IPv4 or IPv6 Reassign-detailed
  - IPv4 or IPv6 Reallocation
- Via Reg-RWS

#### **Problem Statement**



Since the introduction of simple-reassignment some years ago, it is no longer necessary to allow for third-parties (such as upstream ISPs) to create organization records for another entity (such as their customers). In particular, many entities find that spurious organization records are routinely created in their name, causing both confusion and entity + staff time for clean-up.

Therefore, this policy establishes that organization records shall be created only by the entity represented by the organization record, and should be created only through an explicit request to ARIN. ISPs wishing to reassign space to customers should either ask the customer for their ORG-ID or shall use the "simple reassignment" method which does not require nor create new organization records. ISPs wishing to reallocate space to customers should ask the customer for their ORG-ID.

#### **Draft Policy Text**



Add new section(s) into the NRPM:

- 3.X Directory Service Records
- 3.X.1 Organization Record Creation

New organization records shall be created upon ARIN receiving a request directly from an authorized contact representing an entity that ARIN is able to validate. Organization records shall not be created upon the request of third-parties.

# What is the effect of this change? (ARIN)



- Only an authorized representative of an organization which has been verified by ARIN can create an org-id
- ISPs which wish to add or update reallocation or reassign-detailed records must use an org-id that has already been created in the ARIN database

# What are the desired outcomes of this change?

- Reduction in the number of inaccurate orgids in the ARIN database
  - Every new org-id will be created by an authorized representative of the organization
- Reduce the number of org-ids associated with a single organization
  - Today many "duplicate" org-ids are created when providers just create new org-ids instead of reusing existing ones
