Policy Activity since ARIN 45

 - **Goal:** Thoroughly review and suggest changes to ARIN's Policy Development Process that serve the needs of ARIN and its community for 2020 and beyond.
- NRPM Clean Up Working Group
 - **Members:** Owen DeLong, Christian Tacit, Joe Provo
 - **Goal:** Thoroughly review the current NRPM section by section, make holistic suggestions for editorial and substantive policy improvements.
- Policy Experience Report Working Group
 - **Members:** Alison Wood, Alyssa Moore, Anita Nikolich, Chris Woodfield
 - **Goal:** Review recent Policy Experience Reports and suggest policy changes that address community concerns noted by staff.

PDP Improvements Working Group

- The Working Group is finalizing a new draft of the PDP to send to the board for approval.
- The new draft aims to provide a more user-friendly document that makes finding the answers to procedural questions easier.
- It also seeks to add some slight modifications to the procedures for emergency policy suspension and emergency policies to provide additional protections for the community


NRPM Clean Up Working Group

- Selected seven significant areas of opportunity:
 - Section 4 Modernization (identified by ARIN staff)
 - Section 6 internal consistency
 - Straggler "free pool" language and concepts
 - Policy duplication, notably between sections 4 and 8
 - Section 8 alignment for ASN-only holdings and transfers
 - Extract definitions out of specific policy stanzas into section 2
 - Clarifying service provide language to cover modern (eg, cloud) scenarios
- Several of these initiatives are interlocking and broad.
- Started on large but purely editorial changes covering sections 2, 4, and 6.
 - This resulted in the current Draft Policy ARIN-2020-9.
- Next focus is Section 6 with other smaller work items in parallel

Policy Experience Report Working Group

- Reviewed Policy Experience Reports from past two years for issues not yet addressed via policy proposals.
- Examined outstanding items and worked with Registration Services to determine current relevance.
- Collaboratively authored policy proposals to address relevant, unaddressed issues
- Policy Proposals submitted:
 - ARIN-2020-5 (in Last Call)
 - ARIN-2020-6 (Draft Policy)
 - ARIN-2020-7 (Draft Policy)
 - ARIN-2020-8 (Draft Policy)
- No new Policy Experience Report was submitted at ARIN 46
- WG will become ad-hoc after remaining outstanding issues are reviewed.
