- Since ARIN 46
 - Policy ARIN-2020-9 accepted as editorial in Mar 2021
 - Submitted proposal in Jan 2021, now draft policy ARIN-2021-1
- Next Steps:
 - Several work items still on hold until after potential adoption of 2020-9
 - Additional work on sections 2 and 6 in progress
 - Incorporation of feedback from recent PPML threads
 - Continuing to normalize purely editorial language

Policy Experience Report Working Group

- Chair: Alison Wood
- Since ARIN 45:
 - Submitted proposal in July 2020
 - Now Recommended Draft Policy ARIN-2020-7
- Since ARIN 46:
 - No issues were identified
- Next steps:
 - Waiting for post-ARIN 47
