AfriNIC the New Registry

- We have successfully completed all the transition activities
 - Transfer of Member information
 - Transfer of registration information
 - Billing transfer

- AfriNIC started its full operations two month ago:
 - All requests from Africa are received at hotmaster@afriNIC.net
 - Ticketised request tracker
 - Application of AfriNIC policies

AfriNIC structure

- To handle the changes and evolution of the re-organisation, AfriNIC has started to deploy its HR plan. Today, 4 persons work for AfriNIC and a 5th will join soon.

- A CFO has been hired
 - Harish Gowrisunkur
 - An additional Engineer has been hired
 - Franklin Nnebe (starting in the coming month)
 - To be hired soon
 - 1 addition Host/Webmaster
 - 1 System Engineer

Extra-office HR development

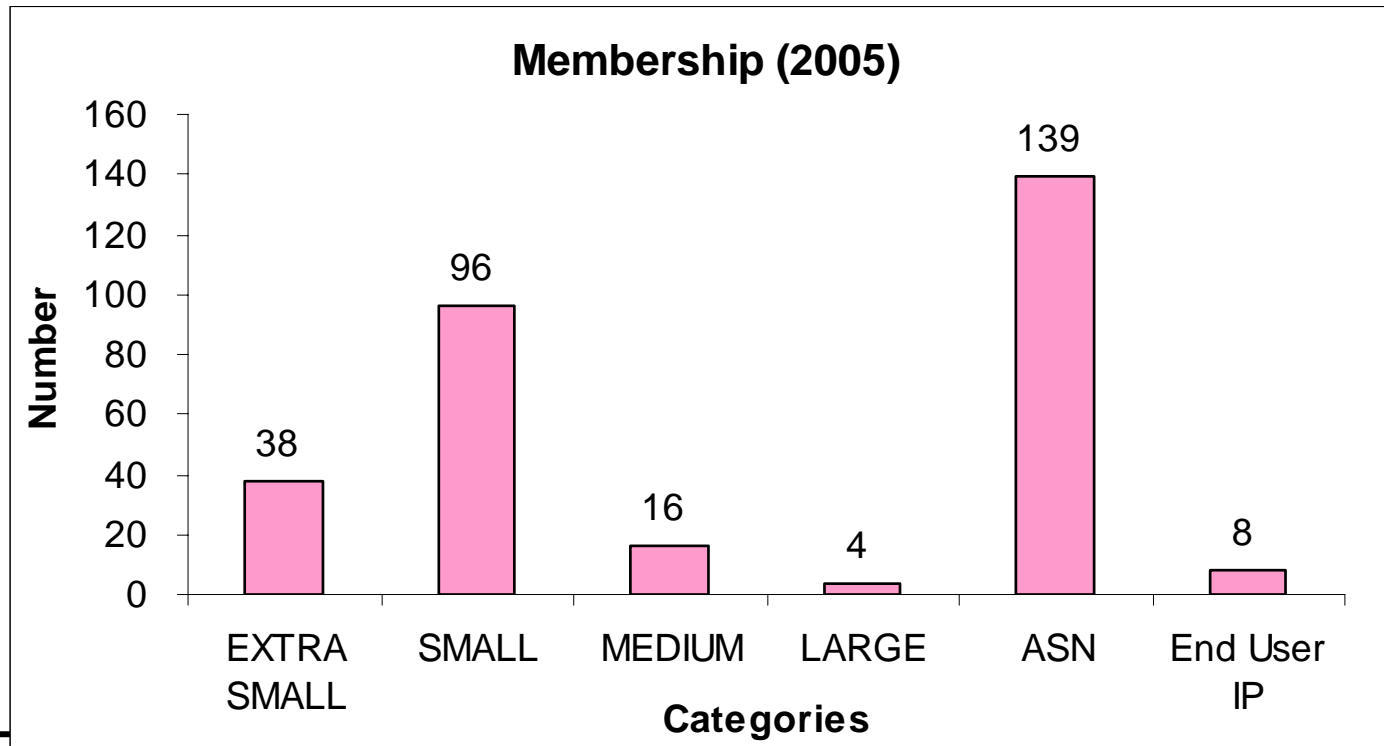
- Ernest has taken the lead in this area 😊! It is a baby girl: **Isabelle**

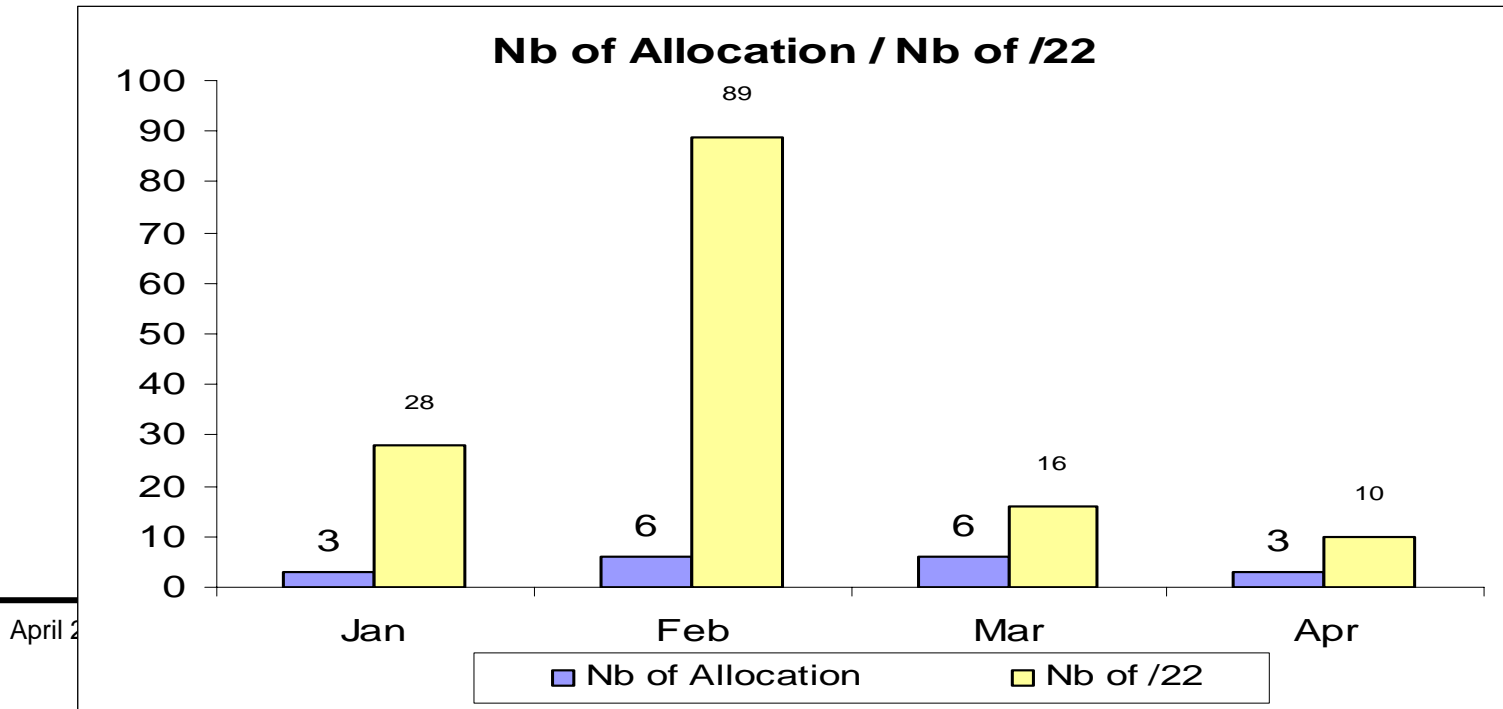
Membership status

- At the startup of Afrinic's full operation as an RIR, we had (as transferred from other RIRs):



Since February 2005

- We have got:
 - 10 New members
 - 7 have completed their process (Paid)
- Allocations: 15 Allocations, and 143 /22

- Since February
 - 1200 new requests received
 - 14% Spam complaint
 - ~3% Junk
 - More than 2000 e-mails in different request queues (new-member and hostmaster)!

- Continue our awareness program:
 - Participation to the WSIS Africa prepcom meeting in Accra.
 - AfriNIC has participated in different panels on Internet Governance and Number Resources Management.
 - Organisation of two Public Policy meetings per year:
 - AfriNIC-2: Maputo (26 & 27 April 2005)
 - AfriNIC-3: Cairo (22-24 November 2005)
 - Training program
 - LIR training program has been developed in English and French
 - One day training is organised on April 23rd (both in French and English)
