### **U.S. Senate**

• **S.773** - A bill to ensure the continued free flow of commerce within the United States and with its global trading partners through secure cyber communications, to provide for the continued development and exploitation of the Internet and intranet communications for such purposes, to provide for the development of a cadre of information technology specialists to improve and maintain effective cybersecurity defenses against disruption, and for other purposes. (Senate Commerce, Science, and Transportation)

- "Regardless of whether or not it is desirable to regulate content on the Internet from a policy perspective, the question becomes moot unless it is technologically possible to do so in a meaningful way."



### CRTC

- In the past year, research and stakeholder consultation through the New Media Project Initiative has identified several key issues concerning highquality Canadian new media broadcasting content, including:
  - the need for increased support for Canadian new media broadcasting content;
  - the need to promote Canadian content in a global new media broadcasting environment;
  - the need to study the impact of traffic management techniques on new media broadcasting insofar as they may impair access to Canadian content;
  - and the need for clearer definitions concerning new media broadcasting.



### **Industry Canada**

 Like the first report, this updated study does not address public policy issues, but again focuses solely on issues of technological feasibility.
